<p style="text-align: center;"><b>Race 1</b></p> <p>SPORTSBET MAKE IT LOOK EASY</p> <p style="text-align: center;">10:41 am 300m Tier 3 - Maiden</p>	<p>Remo Adalli – Late scratching at 10.15am due to the greyhound being on season GAR 77. A 28 day stand down period was imposed.</p> <p>Aston Lynda went up with the lids and was very slow to begin.</p> <p>Grand Stride underwent a post-race veterinary examination and was re-examined following race 3- no apparent injury was reported. Stewards spoke to Mr Peter Barry regarding the racing manners of Grand Stride over the concluding stages of the event. After hearing submissions from Mr Barry, viewing the available race footage and having their own observations, the Stewards issued a warning to connections.</p> <p>Son Of Duke underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Mr Peter Barry regarding Son Of Duke's racing manners approaching the winning post. Acting under the provisions of GAR 124, Son Of Duke was charged with failing to pursue the lure with due commitment. Mr Barry pleaded guilty to the charge. Son Of Duke was suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>

<p style="text-align: center;"><b>Race 2</b></p> <p>GREYHOUND ADOPTION PROGRAM</p> <p style="text-align: center;">10:56 am 350m Tier 3 - Maiden</p>	<p>Race day samples were taken from He's Tangles and Aston Angelo at the trainer's kennel on 1 February 2024.</p> <p>Same Nightmare – New declared weight of 33.0kg, last raced at 34.5kg.</p> <p>Forward Step underwent a post-race veterinary examination and was found to have a right hind toe injury. A 7 day stand down period was imposed. Stewards spoke to Mr Joe Uglietta regarding Forward Step's racing manners approaching the winning post. Acting under the provisions of GAR 124, Forward Step was charged with failing to pursue the lure with due commitment. Mr Uglietta pleaded not guilty to the charge. Forward Step was found guilty and suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted. Supplementary Report 16/02/2024: Trainer Joe Uglietta made application for a review of the greyhounds penalty imposed to the Stewards. Upon review, Stewards established Forward Step had previously been charged under GAR 125 for Failing to Pursue by reason of injury on 4 March 2023. Forward Step has subsequently completed more than 10 clear starts after the first offence and should have been afforded the dispensation under the conditions of GAR 128. After considering the prior offence, the greater than 10 clear starts, and the injury found at this meeting on 2 February 2024, Stewards have amended the penalty to be imposed under GAR 125 by reason of injury at Healesville.</p> <p>Stewards spoke to Mr Gerry Orr the trainer of Same Nightmare, after the greyhound stayed in the starting boxes and took no competitive part in the event. Stewards deemed the performance unsatisfactory. Acting in accordance with GAR 129, Same Nightmare must perform a Satisfactory Trial pursuant to GAR 132, before any future nomination will be accepted.</p>
