Regal Rhode was suspended for 28 days at Healesville and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.

Mikado Eclipse (faltered soon after the start and subsequently tailed off) underwent a post-race veterinary examination and was found to have injuries to the left calf and left quadriceps muscles. A 21 day stand down period was imposed.
