Acting under the provisions of GAR 124, Devil's Knocking was charged with failing to pursue the lure with due commitment. Mr. Galea reserved his plea to the charge. Devil's Knocking was found guilty and suspended for 28 days at Geelong and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
