A 10 day stand down period was imposed. Stewards spoke to Mr Glenn Judd regarding Moraine Jackal's racing manners on the first turn. After hearing submissions from Mr Judd, viewing the available race footage and acting on their observations, Stewards deemed the performance of Moraine Jackal unsatisfactory. Moraine Jackal must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.

Mr Brennan pleaded guilty to the charge, Reiko Dusty was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.
Silent Bullet underwent a post-race veterinary examination and was found to have left fore spike wound. No stand down period was imposed. Stewards spoke to Mr. Peter Inguanti regarding the racing manners of Silent Bullet in the home straight. After hearing submissions from Mr Inguanti, viewing the available race footage and having their own observations, the Stewards issued a warning to connections regarding the greyhound's racing manners.
