A 28 day stand down period was imposed. A veterinary follow up has been ordered for Cashing Cheques and Stewards will require a veterinary certificate pursuant to GAR 19(3)(w) before any future nominations will be accepted.

Supplementary report 21/05/24: Stewards spoke to Mr. Craig Treherne regarding Cashing Cheques' performance and racing action approaching the 200m mark. The Stewards deemed the performance of Cashing Cheques' unsatisfactory. Cashing Cheques' must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted. Trainer Craig Treherne notified Stewards in accordance with GAR 122 that Cashing Cheques was found to have a torn left hip support.

Without Reason – 6 month – Solo, Distance: 300m, Weight: 32.1kg, Box 1, Time Run 17:290 – Comment: Cleared All Tracks.
