Shotgun Shaka was slow to begin.</p> <p>Poor Old Percy - contacted running rail approaching first turn, underwent a post-race veterinary examination and was found to have bruising to the left shoulder and left hip. A 3 day stand down period was imposed.</p> <p>Shotgun Shaka (trailed field) underwent a post-race veterinary examination – no apparent injury was reported. Re-vet declined.</p> <p>Stewards spoke to trainer Mrs D Bewley regarding Shotgun Shaka's overall performance. After hearing submissions from Mrs D Bewley, viewing the available race footage and acting on their observations, Stewards deemed the performance of Shotgun Shaka unsatisfactory. Shotgun Shaka must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p>
