Darnum Dazzler ran back in the opposite direction and subsequently the event was converted into a finish-on lure. A 10 day stand down period was imposed. Stewards spoke to Mr. Peter Handley regarding Darnum Dazzler's racing manners on the first turn. Acting under the provisions of GAR 125, Darnum Dazzler was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Handley pleaded guilty to the charge. Darnum Dazzler must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted. - Sorceress, Secrets Without and Just Angelic were reported to have no apparent injury. - Harvington was found to have a left wrist sprain. A 7 day stand down period was imposed. - Water Bomb was found to have a spike wound to the left hind toe. A 5 day stand down period was imposed. - Concrete Egan was found to have a left monkey muscle injury. A 7 day stand down period was imposed.
