Our Lulu must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

Avon Swan was checked by Our Lulu on the first turn, faltered and subsequently tailed off. Avon Swan underwent a post-race veterinary examination and was found to have a right back muscle injury. A 60 day stand down period was imposed.

Target Range underwent a post-race veterinary examination at the trainer's request and was found to have a left fore spike wound. A 5 day stand down period was imposed.
