After hearing submissions from Mr. Onley, viewing the available race footage and having their own observations, Stewards took no further action</p> <p>Alazne faltered on the first turn and subsequently lost ground, underwent a post-race veterinary examination and was found to have a right foreleg long head triceps injury. A 7 day stand down period was imposed.</p> <p>Arkstorm faltered on the first turn and subsequently lost ground, underwent a post-race veterinary examination and was found to have a right hindleg back muscle injury. A 14 day stand down period was imposed.</p>
