After hearing submissions from Mr. Fulford, viewing the available race footage and acting on their observations, Stewards deemed the performance of Opal Key unsatisfactory. Opal Key must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted. Stewards spoke to the return gate attendant and reminded them of their responsibilities. This matter was referred to the Club Manager for further consideration and remediation.
