Black Jester (visibly eased and turned it's head outwards in the home straight), underwent a post-race veterinary examination and was re-examined following race 11. Black Jester was found to have a right carpal sprain. A 10 day stand down period was imposed.

Stewards spoke to representative Mr. K. Blake regarding Black Jester's racing manners in the home straight. Acting under the provisions of GAR 125, Black Jester was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Blake pleaded guilty to the charge. Black Jester was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.
