<b>Race 1</b> SPORTSBET BET WITH MATES (275+RANK) 2:54 pm 500m Maiden	Droopy Max and Vulcan Icon were slow to begin. Droopy Max and Destini Seahawk raced wide in the home straight.
<b>Race 2</b> BENDIGO ADVERTISER (275+RANK) 3:10 pm 425m Maiden	Aston Bianca – Late scratching at 2:09pm due to weight variation (GAR 101). A 10 day stand down period was imposed. Trainer, Mr. A. Symons was fined \$100.  Major Molly and Bonnieville Icon were slow to begin.  Oriental Garnet (severely checked soon after the start), underwent a post-race veterinary examination and was found to have a left pencil muscle injury and a left triangle muscle injury. A 28 day stand down period was imposed.  A post-race sample was taken from She's Extreme - the winner of the event.

Tilly Tornado underwent a post-race veterinary examination at the trainer's request and was found to have a right groin injury. A 14 day stand down period was imposed.

Acting under the provisions of GAR 123, Wild Aussie was charged with marring. Mr. Chircop pleaded guilty to the charge. Wild Aussie is suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
