Stewards spoke to Ms Jennifer Torr regarding Radical Rex's aggressive behaviour towards the greyhound Bounty Chief following the event, at the finish on lure. After hearing submissions from Ms. Torr and Steward Mr Jaden Smith, Stewards deemed the behaviour of Radical Rex unsatisfactory. Radical Rex must perform a Satisfactory Trial in accordance with GAR 131(1)(d), and pursuant to GAR 132, before any future nomination will be accepted.
