Race 1 SPORTSBET BET WITH MATES (300+RANK) 3:29 pm 425m Maiden	<p>Lamia Mimma was quick to begin.</p> <p>Yum Cha Mac (faltered approaching the home turn and pulled up) underwent a post-race veterinary examination and was found to have a left monkey muscle injury and a right chest injury. A 28 day stand down period was imposed.</p> <p>A post-race sample was taken from Lamia Mimma – the winner of the event.</p>
Race 2 BENDIGO ADVERTISER (300+RANK) 3:47 pm 425m Maiden	<p>Lamia Stud was slow to begin.</p> <p>Aston Dahlia (severely checked approaching the first turn) underwent a post-race veterinary examination and was found to have a right monkey muscle injury. A 7 day stand down period was imposed.</p> <p>A post-race sample was taken from Kraken Mask – the winner of the event.</p>
Race 3 HIP POCKET BENDIGO (300+RANK) 4:04 pm 425m Grade 7	<p>Trainer Ms A.Hemingway was fined \$50 for failing to ensure the registration card was produced for Alonzo Thrills, pursuant to GAR 88.</p> <p>A pre-race sample was taken from Quest For Luck.</p> <p>Jack's Regret, Kraken Missiles and Quest For Luck were slow to begin. Jack's Regret and Kraken Missiles raced wide in the home straight.</p> <p>Aston Finlay (fell on the first turn) underwent a post-race veterinary examination and was found to have bruising to the right ulna region. A 10 day stand down period was imposed.</p> <p>Jerome (turned its head inwards and marred the running of Aston Bruno in the home straight) underwent a post-race veterinary examination – no apparent injury was reported.</p> <p>Stewards spoke to Trainer Mr P.Frost regarding Jerome's racing manners in the home straight. Acting under the provisions of GAR 123, Jerome was charged with marring. Mr Frost pleaded guilty to the charge. Jerome was found guilty and suspended for 28 days at Bendigo and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
