A 7 day stand down period was imposed. Stewards spoke to Mr Joe Uglietta regarding Two reasons's racing manners in the home straight. Acting under the provisions of GAR 125, Two Reasons was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Uglietta pled guilty to the charge, Two Reasons was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>

No stand down period was imposed.</p>

Stewards spoke to Ms Kerry Minne regarding Kylie Turban's racing manners on the home turn and in the home straight. Acting under the provisions of GAR 124 Kylie Turban was charged with failing to pursue the lure with due commitment. Ms Minne pled not guilty to the charge, Kylie Turban was found guilty and suspended for 28 days at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p>
