<p>Race 1 A1 SIGNAGE (300+RANK) 5:51 pm 390m Maiden</p>	<p>A pre-race sample was taken from Fernando Zoom.</p> <p>The start was delayed by approximately two minutes to allow the Starter to manually re-test the starting boxes.</p> <p>Kayden's Cuddles was slow to begin.</p>
<p>Race 2 SJC CONCRETING (300+RANK) 6:09 pm 450m Maiden</p>	<p>Sir Sugar was slow to begin.</p> <p>Aston Hamrun [stumbled soon after the start and lost considerable ground], underwent a post-race veterinary examination and was found to have injuries to the right wrist and right triceps. A 10 day stand down period was imposed.</p> <p>Trainer - Mr. S.McDonnell was queried as significant betting fluctuations were observed by Stewards on What Style in this event. The comments of Mr. McDonnell were noted. A post-race sample was taken from What Style – placed 3rd in the event.</p>
<p>Race 3 SPORTSBET BET WITH MATES (300+RANK) 6:27 pm 390m Grade 7</p>	<p>Aston Japan was quick to begin. Last Crack was slow to begin.</p> <p>Hello Sarah underwent a post-race veterinary examination and was found to have a right carpal sprain. A 5 day stand down period was imposed. Stewards spoke to Trainer, Ms. K. Jackson, regarding the racing manners of Hello Sarah approaching the finishing line. Acting under the provisions of GAR 125, Hello Sarah was charged with failing to pursue the lure with due commitment (by reason of injury). Ms. Jackson pleaded guilty to the charge. Hello Sarah was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>

After viewing the footage and acting on their own observations, the Stewards were comfortably satisfied that no greyhounds were materially affected so as to affect the outcome of the event.
