My Own Voice underwent a post-race veterinary examination - no apparent injury was reported. Stewards spoke to Trainer Ms Hannah Barravecchio regarding the behaviour of My Own Voice in escaping the catching pen. The Stewards hold concerns that this poses an unnecessary safety issue for My Own Voice, for other greyhounds in the race and staff that triage these types of incidents. After considering submissions from Ms Barravecchio, a warning was issued that further such instances of this nature may result in My Own Voice being placed on a conditional satisfactory trial in accordance with GAR 129.

Redshift Papa underwent a post–race veterinary examination at the trainer's request and was found to have a left hindleg triangle injury. A 14 day stand down period was imposed.
