Satisfactory Trial Results - Taquitos trialed over the 311 metres from box 1, weight 31.2kg, the greyhound was placed 1st in a field of 4. The time of the trial was 18.35, the greyhound won by a margin of 1.00 lengths. Taquitos was cleared.
