Son Of Duke was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Whiskey Flash was severely checked turning off the back straight and lost ground, underwent a post-race veterinary examination and was found to have a left fibula injury, a spike wound to the right fore dew claw and an abrasion to the left hind metacarpal. A 10 day stand down period was imposed.</p>
