Mr. Kama subsequently left the race meeting.</p> <p>Pursuant to GAR 75(7), Steward Ms. Callie Wilson did not act in any official capacity for this event.</p> <p>Pommel Boy was slow to begin.</p> <p>Velvet Vixen lost ground over the concluding stages, underwent a post-race veterinary examination and was found to have a right hind triangle muscle strain. A 5 day stand down period was imposed.</p>

Stewards spoke to trainer Mr. Gerry Orr regarding the greyhound's performance. Mr. Orr advised Stewards that he expected the greyhound to perform consistent to its market expectations in tonight's event, but was positive about the early speed shown by Cannoneer. Mr. Orr added that he intends to further build the greyhound's racing capacity to be competitive at 525m or similar distances. Mr. Orr said he will assess the greyhound in the coming days to determine its next racing engagement and whether it will continue to race at a similar distance. Stewards noted these comments.</p>
