MEETING CONDITIONS:

Track curator L Rowe, advised Stewards the track was medium harrowed on Thursday 4 December 2014.

Love To Love and Alfred Benz collided soon after the start. Marmion Star, Gaelic Flame, Thunder Storm, Need's Luck and Spooked collided soon after the start, checking Thunder Storm, Gaelic Flame, Spooked and Need's Luck, Need's Luck raced wide as a result. Thunder Storm, Spooked and Gaelic Flame collided at the 300m mark, checking Spooked and Gaelic Flame. Thunder Storm galloped on the heels of Magic Kara at the 200m mark. Gaelic Flame and Alfred Benz collided at the 150m mark. Gaelic Glame and Spooked collided at the 50m mark.

Acting under GAR 69(B)(1), the stewards charged Latte For Sandra with failing to pursue the lure with due commitment (by reason of injury). S Elmes pleaded not guilty to the charge, Latte For Sandra was found guilty and stewards directed that the greyhound perform a Satisfactory Trial (all tracks) pursuant to GAR 69(B)(1)(a), before any future nomination will be accepted.

Acting under GAR 69(A)(1) stewards charged Walter Miti with failing to pursue the lure with due commitment. S Collyer pleaded guilty to the charge, Walter Miti was found guilty and suspended for 28 days at Healesville and directed that the greyhound perform a Satisfactory Trial (all tracks), pursuant to GAR 69(2)(A)(a) before any future nomination will be accepted.

Stewards spoke to S Collyer regarding the direction that the greyhound Walter Miti be boxed first. Acting under GAR 52(2) Stewards directed that this box first be removed.
