A post-race veterinary examination revealed a right carpal sprain and a left back muscle injury. A 14 day stand down period was imposed. Stewards spoke to Trainer Mr. Daniel Hoch, the trainer of Pride Of Essay regarding its performance in this event. After hearing submissions from Mr. Hoch, viewing the available race footage, and acting on their observations, the Stewards deemed the performance of Pride Of Essay unsatisfactory. Pride Of Essay must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted.</p>
