<b>Race 2</b> JVM GREEN LIGHT ON PODCAST (275+RANK) 11:27 am 300m Maiden	Misty Mia and Como Prince were slow to begin.  Como Prince and No Charge raced wide throughout the event.  A post-race sample was taken from No Charge – the winner of the event.
<b>Race 3</b> GREYHOUND CLUBS VICTORIA (275+RANK) 11:42 am 350m Maiden	Silver Streak was quick to begin. Mad Kev was very slow to begin.  Waltzing Soprano raced erratically from the 300m mark to the 150m mark, underwent a post-race veterinary examination and was found to have a cervico-thoracic injury. A 5 day stand down period was imposed. Stewards spoke to representative Gavin Ithier regarding the racing manners of Waltzing Soprano. After hearing submissions from Mr Ithier, viewing the available race footage and having their own observations, the Stewards issued a warning to connections.
