Weblec Aviator was suspended for 28 days at Geelong track only and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.</p> <p>Nashville Bale underwent a post-race veterinary examination and was found to have a right wrist injury. A 5 day stand down period was imposed. Stewards spoke to Mr. Thomas Daily regarding the racing manners of Nashville Bale in the home straight. After hearing submissions from Mr. Daily, viewing the available race footage and having their own observations, the Stewards issued a warning to connections.</p>
