Race 6 JVM GREEN LIGHT ON PODCAST (275+RANK) 1:05 pm 350m Grade 5 Laquita Star – Late scratching at 10:46am due to non-arrival with Stewards permission (GAR 86 and LR 39).

Pursuant to GAR 75(7), Steward Ms Demi Barber did not act in any official capacity for this event.

Enraged began awkwardly and was very slow to begin.

Enraged underwent a post-race veterinary examination - no apparent injury was reported.

Golden Coast underwent a post-race veterinary examination at the request of the trainer and was found to have an abrasion on the right hind foot. No stand down period was imposed.

Race 7 JASON McKEOWN PHOTOGRAPHY (275+RANK) 1:24 pm 350m Grade 5	Remo Rodman – Late scratching at 10:36am due to weight variation (GAR 101). A 10 day stand down period was imposed. Trainer, David Plumridge was fined \$100. River Matt was slow to begin.
Race 8 "THE SHED" @ HEALESVILLE GREYS (275+) 1:44 pm 350m Grade 5	A pre-race sample was taken from Howe Pie. Pacific Pearl and Mighty Innings were quick to begin. Revesby Bale was slow to begin.
Race 9 CROYDON HOMING PIGEON CLUB (275+RANK) 2:04 pm 300m Grade 6	Race day samples were taken from Cherry Red and We Are South at the trainer's kennels earlier today. Pursuant to GAR 75(7), Steward Ms Demi Barber did not act in any official capacity for this event. A pre-race sample was unable to be obtained from Thai Butterfly, a post-race sample was subsequently taken. Topology Man was slow to begin.
Race 10 STRAIGHT RACINGGREAT RACING (275+) 2:24 pm 300m Grade 5	Paddy Almighty was slow to begin. Caliah's Crew turned it's head outwards and visibly eased at the 100m mark. Underwent a post-race veterinary examination and was found to have a left foreleg shin soreness. Stewards spoke to Mr. Louie Bicchieri regarding Caliah's Crew's racing manners at the 100m mark. Acting under the provisions of GAR 125, Caliah's Crew was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Biccheri pleaded not guilty to the charge. Caliah's Crew was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted. La Lina turned head inwards at the 100m mark. Underwent a post-race veterinary examination and was found to have a left sartorius muscle injury. A 10 day stand down period was imposed. Stewards spoke to Mr. Stavros Kipirtidis regarding La Lina's racing manners at the 100m mark. Acting under the provisions of GAR 124, La Lina was charged with failing to pursue the lure with due commitment. Mr. Kipirtidis pleaded not guilty to the charge. La Lina was found guilty and suspended for 28 days at all tracks and must perform a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted.
Race 11 OUTER EAST FOOTBALL NETBALL COMP (275+) 2:42 pm 300m Grade 5	Dreaming Star – New declared weight of 28.9kg, last raced at 30.4kg. Dreaming Star stumbled soon after the start and lost considerable ground, underwent a post-race veterinary examination - no apparent injury was reported. Twisted Bliss faltered approaching the 100m mark and lost ground, underwent a post-race veterinary examination and was found to have an injury to the left carpal bone. A 14 day stand down period was imposed.
Race 12 SPORTSBET BET WITH MATES (275+RANK) 3:02 pm 300m Grade 5	A pre-race sample was taken from Inter Cyborg. Mt. View Buck was slow to begin. Kraken Attila lost ground from the 150m mark, underwent a post-race veterinary examination and was found to have an abrasion on the right hind foot. No stand down period was imposed. Mr Brent Merton declined the option to have the greyhound re-examined. Stewards spoke to Mr. Merton regarding Kraken Attila's performance following the 150m mark. After hearing submissions from Mr Merton, viewing the available race footage and acting on their observations, Stewards deemed the performance of Kraken Attila's unsatisfactory. Kraken Attila must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted. Mr. Merton advised that he intends to retire the greyhound.
