Acting under the provisions of GAR 125, Caliah's Crew was charged with failing to pursue the lure with due commitment (by reason of injury). Mr. Biccheri pleaded not guilty to the charge. Caliah's Crew was found guilty and must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted

La Lina turned head inwards at the 100m mark. Underwent a post-race veterinary examination and was found to have a left sartorius muscle injury. A 10 day stand down period was imposed. Stewards spoke to Mr. Stavros Kipirtidis regarding La Lina's racing manners at the 100m mark. Acting under the provisions of GAR 124, La Lina was charged with failing to pursue the lure with due commitment. Mr. Kipirtidis pleaded  $not\ guilty\ to\ the\ charge.\ La\ Lina\ was\ found\ guilty\ and\ suspended\ for\ 28\ days\ at\ all\ tracks\ and\ must\ perform$ a Satisfactory Trial in accordance with GAR 127, and pursuant to GAR 132, before any future nomination will be accepted

After hearing submissions from Mr Merton, viewing the available race footage and acting on their observations, Stewards deemed the performance of Kraken Attila unsatisfactory. Kraken Attila must perform a Satisfactory Trial in accordance with GAR 129, and pursuant to GAR 132, before any future nomination will be accepted. Mr. Merton advised that he intends to retire the greyhound.
