Freaky Freddie was slow to begin.</p> <p>Got Ink underwent a post–race veterinary examination at the trainer’s request and was found to have a right metacarpal fracture. A 90 day stand down period was imposed.</p> <p>Booker Knowledge lost ground entering the home straight, underwent a post–race veterinary examination and was found to have a left groin injury.
