Stewards heard submissions from Trainer Mr. Keith Lloyd concerning Sonic Sonny's racing manners. Additionally, Stewards viewed the available race footage and acted upon their own observations. Stewards formed the opinion that the initial collision between Serenity Girl and Sonic Sonny at the top of the home straight was the consequence of both greyhounds attempting to secure a run to the inside of the leader Riverdale Clyde. Serenity Girl and Sonic Sonny subsequently collided multiple times in the home straight, causing both greyhounds to become unbalanced and severely checking Aston Baht. Stewards were satisfied that, whilst Sonic Sonny collided multiple times with Serenity Girl in the home straight, Sonic Sonny's racing manners did not constitute a breach of the rules. Stewards took no further action. |
