Stewards spoke to trainer Mr Reginald Marriner regarding Pirate's Brew's racing manners in the home straight. Acting under the provisions of GAR 125, Pirate's Brew was charged with failing to pursue the lure with due commitment (by reason of injury). Mr Marriner pleaded guilty to the charge. Pirate's Brew must perform a satisfactory trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.</p>
