Dewana Payout must perform a Satisfactory Trial in accordance with GAR 125, and pursuant to GAR 132, before any future nomination will be accepted.

Stewards also spoke to Mr. Dewan regarding the difficulty in boxing Dewana Payout in this event. A warning was issued pursuant to GAR 106(2) and Stewards will continue to monitor the box manners of Dewana Payout at future starts.
